FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS

1.

He/She presides over all the members of the General Body and Executive Committee. He/She can cast his vote in the case of a tie in the decision making. He/She can supervise all branches of the Society

2.

He/She shall assist the president in discharging his functions. In the absence of the President he will perform the duty of the President as entrusted by the President.

GENERAL SECRETARY 3.

He/She is the Chief Executive officer of the Society and Custodian of all records relating to the Society and correspondent on behalf of the Society. He/She has to take on record all minutes of the Society. Would convene both the Executive Committee and General Body of the Society with permission of the president. He/She guides the Treasurer in preparing the budget and expenditure statement to place before the Governing Body for approval.

General Secretary is exclusively authorized to open and operate Bank Accounts and operate to barrow funds from Banks & Financial Institutions and execute all necessary documents to obtain such loans on behalf of the society.

General Secretary is further authorize to enter in to agreements on behalf of the society with Govt., Universities, Local oodies, Companies, Firms and Individuals.

4.

He/She has to do the work entrusted by the Executive Committee. He/She has to assist the Secretary in discharging his duties. In the absence of the Secretary, he/she can perform the duties of the secretary.

5.

He/She is the responsible for all financial transactions and funds of the society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the Society jointly with the Secretary or President.

6.

1/3 (One Third) of the total members for General Body Meeting and 1/4 for Executive Committee meeting.

7.

The investment of funds of the Society shall be made in accordance with the provision of Section 11(5) of the Incom Tax Act, 1961.

8.

The Accounts of the Society would be maintained as required under the applicable laws and statues and the Charted Accountant will carry out an audit of the accounts.

No Amendments or alteration shall be made in purpose of the association unless it is voted 2/3rd of its members present at a special meeting convened for the purpose and confirmed by 2/3rd of the members present and confirmed in second meeting


